(Correction) Partial Corrections to Past Consolidated Financial Reviews, Securities Reports and Others

Tokyo Electron Limited (TEL) hereby announces that there are matters that should be corrected in Consolidated Financial Reviews and Quarterly Consolidated Financial Reviews that TEL disclosed in the past. However, these corrections will have no impact on business results, and consolidated financial statements and non-consolidated financial statements are appropriate. There will not be any corrections to consolidated financial statements or non-consolidated financial statements for past fiscal years.

Furthermore, in association with this matter, TEL will today submit corrected reports relating to Securities Reports and Quarterly Reports for this period to the Kanto Finance Bureau.

1. Background and Reason of Corrections

In regard to Tokyo Electron America, Inc. (TEA), a U.S. subsidiary of TEL, it was discovered that there were incorrect figures for consolidated orders and consolidated order backlogs that TEL disclosed for each quarter, as a result of problems regarding the tabulation program for orders and order backlogs. From 2005, when TEA introduced this tabulation program, errors in the range of a 0.4% understatement to a 1.9% overstatement regarding TEL's quarterly consolidated orders arose, and as these differences continued and accumulated, the order backlog at the end of June 2016 was reported by an excess of approximately 10,400 million yen, equivalent to 2.8% of TEL's consolidated order backlog.

This tabulation program was locally developed by TEA to compile orders and order backlogs from data in the sales-related core system, and a problem arose where the tabulation of order data for specific transactions was duplicated. Overseas subsidiaries other than TEA do not use this program. Investigating whether there were errors in orders and order backlogs at the other overseas subsidiaries, it was confirmed that there were no problems apart from the one involving TEA.

Recently, we discovered the cause of the problem with the program, corrected its incorrect logic, and calculated corrected orders and order backlogs; and consequently figures are being corrected. As previously mentioned, errors were recognized in consolidated orders and consolidated order backlogs that TEL disclosed from 2005 onward. However, in regard to the partial correction of past Financial Reviews, Securities Reports, and Quarterly Reports, we have taken into account the public inspection period for Securities Reports and

Quarterly Reports, and the degree of impact of the corrected amounts, and decided that TEL will apply corrections to fiscal year Financial Reviews and Securities Reports for the past five years (the past three years for Quarterly Financial Reviews and Quarterly Reports).

Domestic net sales increased 28.2% from the previous year to 121,807 million yen, while overseas net sales increased 4.6% to 542,140 million yen to account for 81.7% of net sales. Orders received during the fiscal year increased 2.8% to 679,320 million yen, but the orders backlog grew 5.2% to 311,143 million yen.
